Release and Waiver of Liability / Assumption of Risk and Indemuty Agreement / Image Rights

1. Risks Associated with Participation

4. Release of Liability

By registering for this Event, I hereby waive, release, and forever discharge, for myself, my heirs, executors, administrators, and legal representatives, any and all rights and/or claims which I may have or may hereafter accrue to me against the Organiser, its officers, directors, employees, consultants, agents, volunteers, and Event sponsors for any and all damages, personal injuries (including death), and/or claims which may be sustained by me or my vehicle directly or indirectly arising out of my participation in the Event (including the application of emergency or medical services at the Event) even if the damages, injuries (including death), and/or claims are caused by the negligence of those persons listed above or otherwise, save that nothing in these Terms and Conditions shall be construed as excluding or limiting the Organiser's liability for personal injury or death arising from its negligence or the negligence of persons under its control. Further, I covenant not to sue the Organiser, its officers, directors, employees, consultants, volunteers, and Event sponsors for any and all damages, personal injuries (including death), and/or claims which may be sustained by me directly or indirectly arising out of my participation in the Event. This release and discharge includes, but is not limited to, claims for personal injury, death, property damage, economic loss, breach of contract, lost wages, contribution, indemnity, punitive damages, negligence, or any other legally recognizable claim arising out of my participation in the Event (including all legal costs associated with such claims).
